# ORDER PHASE A FIRE RESTRICTIONS UMATILLA NATIONAL FOREST

Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are **prohibited** on all National Forest System Lands within the Umatilla National Forest, in the State of Oregon and Washington. This Order is effective from Friday, July 12, 2024, at 12:01 am, until October 31, 2024 or until rescinded.

- 1. Smoking, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter and cleared of all flammable material. 36 CFR § 261.52(d).
- 2. Operating an Internal Combustion Engine 36 CFR § 261.52(h). [Specifically, Chainsaws]
- 3. Operating or using any internal or external combustion engine without a spark arresting device properly installed, maintained and in effective working order in accordance with U.S. Forest Service Standard 5100-1. 36 CFR § 261.52(j).
- 4. Possess or use a vehicle off National Forest System roads. 36 CFR § 261.56
  - a. Except for the purpose of traveling to and from a dispersed campsite with 300 feet of open and developed road. Vehicles must be parked in an area devoid of any vegetation and flammable material.
- 5. Possessing, discharging or using any kind of firework or other pyrotechnic device. 36 CFR § 261.52(f).
- 6. Using an explosive. 36 CFR § 261.52(b).

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Any person is exempt from Prohibition 2, operating a chainsaw, when they have a <u>valid</u> <u>personal use firewood cutting permit</u> and follow the conditions outlined in the permit for woodcutting.
- 4. Any person is exempt from Prohibition 2 when operating a chainsaw between the hours of 8:00 pm to 1:00 pm.

# Assessment of Need and Enforcement Plan

# 1. Background:

The Blue Mountain Fire Danger Operating Plan analyzed historic weather and fire occurrence and fire size. At High Fire Danger, fires have grown to 300 acres or greater at these conditions resulting in large numbers of fire resources needed to suppress unplanned fires. These restrictions have been deemed necessary because of moderated but continuing dry fire conditions from persistent low fuel moistures, humidities and high temperatures which can result in a fire quickly spreading and escaping control.

# 2. Intent of Subpart B Order:

These restrictions are intended to reduce the occurrence of human caused wildfires.

#### 3. Enforcement Plan:

This order will be enforceable by LEOs, FPOs and Special agents. Education will be emphasized during initial implementation phase of this order. Officers will exercise normal discretion in resolving violations. Morning and evening patrols will be emphasized, especially on weekends.

# 4. Posting:

The forest and district staff are responsible for posting this order in a reasonable manner.

#### CIVIL RIGHTS IMPACTS ANALYSIS

# UNITED STATES DEPARTMENT OF AGRICULTURE Forest Service, Pacific Northwest Region (R6) Umatilla National Forest

**Prohibited Acts:** Smoking 36 CFR 261.52(d); Operation of internal combustion engine 36 CFR 261.52(h); Operating or using any internal or external combustion engine without a spark arresting device properly installed, maintained and in effective working order in accordance with U.S. Forest Service Standard 5100-1. 36 CFR § 261.52(j). Use of motorized vehicle off NFS roads 36 CFR 261.56.

# **Purpose:**

The purpose for developing a civil rights impact analysis is to provide the Forest Service decision maker information concerning potential civil rights impacts of the proposed action. Civil rights impacts are those which could affect the agency's ability to ensure equal opportunity in employment and in delivery of programs and services.

# **Favorable Impacts:**

The proposed action would:

Increase public health and safety of Forest visitors and employees during Fire Season.

# **Unfavorable Impacts:**

The proposed action would:

Prohibit the use of any open fire, restrict smoking to an enclosed vehicle or building, Recreation site or area cleared of vegetation and operating internal combustion engine, which could start a Wildfire on National Forest System lands administered by the Umatilla National Forest within the states of Oregon and Washington.

# **Mitigation Measures:**

This order will be evaluated and rescinded or modified as Fire Danger Increases or Decreases across Umatilla National Forest Lands and in coordination with Oregon Department of Forestry and Washington Department of Natural Resources fire restrictions.

# **Social Impacts:**

The proposed action does not impose any unreasonable adverse impacts on the civil rights of any individuals. The area closure applies to all nonexempt personnel. The restriction is temporary. The overall benefits are reasonable, as compared to the unfavorable impacts to public safety.

# **Net Civil Rights Impact:**

No net negative Civil Rights Impacts would occur because the area closure is general in applicability and would apply across the affected area.
